The contestants will wear high heels and a two-piece swimsuit of their choice, no thong suits will be permitted. Jewelry may be worn in this round. No oil may be worn.

Comparison: The contestants will present their full front and rear stance with other contestants wearing their two-piece swimsuits and high heels. Judges will score competitors on “Balance and Shape” and overall physical appearance, including complexion, skin tone, poise and overall presentation.

Finals: The top five (5) competitors in each height class will receive trophies.
