Jewelry may be worn in this round. No oil may be worn. Elimination rounds may be necessary in the round, depending on the number of contestants.

Final Assessment: All competitors will be brought back in their two-piece suits for quarter-turns. The top 5 will then be re-scored and those scores will be added to the prejudging scores for a final score.
